BARUSCH/CASTAGNA REGATTA 2008

The SAN DIEGO CRUISER ASSOCIATION is presently planning to host the 2008 Barusch / Castagna Cruiser Navigation Regatta.

Current plans are to host this regatta in the spring of 2008. Dates for the event are now set for May 29, 30, & 31. San Diego Yacht Club will be the host yacht club this year.

The Pacific Coast Yachting Association (PCYA), representing West Coast yachting organizations and clubs from Vancouver, Canada to San Diego, California, sponsors the Barusch/Castagna Regatta annually.

This regatta brings together the top two cruiser navigation contestants from each of the member West Coast clubs for a three-day venue capped by a 35nm. Predicted Log contest.

The Barusch Trophy goes to the individual skipper who has the best score among all contestants.

The Castagna trophy goes to the yacht club whose skippers collectively score the best among all other club representatives.

FUBAR ODYSSEY 2007 Fleet Underway to BAJA Rally (FUBAR)

Overview:

The Del Rey Yacht Club (DRYC) is proud to present FUBAR ODYSSEY '07 with the partnership and support of Mexico's Tourism Board. This first ever rally will take the fleet of powerboats from San Diego to La Paz, escorted by vessels manned by experienced skippers and with the key support people aboard such as mechanics, doctors, paramedics and boat manufacturers and by the makers of major marine engines, electronics and equipment, etc.

Safe routes will be pre-planned, and a weather routing service has signed on to oversee the entire trip. The schedule will be flexible to accommodate days spent in port waiting for fair weather, etc. Fueling facilities and dockage for shore-side activities, parties, etc. will be pre-arranged at each stop along the way where such facilities exist. If participants wish to take extra days for fishing or whale watching, or if they wish to leave the fleet at any time, that will be permissible.

This DRYC event is open to members of other yacht clubs or any other boat owners who are interested in participating. This event is designed for boats wishing to continue cruising in Mexico, but for those that wish to return at the end of the season (end of May), information about return options will be provided.

Basic Requirements:

Powerboats that are capable of traveling a minimum of 450 nautical miles at 8 knots are invited to enter.

Approximates Schedule:

Fleet will depart San Diego approximately November 7, 2007. Stops along the way will include Ensenada for fueling at optimum prices and clearing into Mexico, Turtle Bay for re-fueling, Santa Maria, Magdalena Bay, Cabo San Jose, Muertos Bay, and ending in La Paz. Parties will be planned at most stops.

Fees:

The modest entry fee of \$500 will be used to to cover the expenses. This fee will accompany the Boat Application and Entry Agreement. Applications opened up on April 1, 2007. See forms and lists page on website for a list of participating boats.

Any profits from this event will benefit the DRYC juniors in Marina del Rey through the Santa Monica Bay Sailing Foundation. Please visit the website below to find out more about FUBAR and the work of this foundation.

DECLARATION OF TRUST GARRETT HORDER MEMORIAL TROPHY

Amended Jan 19, 1999

This DECLARATION OF TRUST is executed this day by the PACIFIC COAST YACHTING ASSOCIATION.

WITNESSETH: That it hereby declared as follows:
PACIFIC COAST YACHTING ASSOCIATION wishing to acknowledge the importance of imparting knowledge and appreciation

of the sport of recreational boating to the youth of our area, hereby dedicates the GARRETT HORDER MEMORIAL TROPHY to the, quality and improvement of boating education by our member associations.

The GARRETT HORDER MEMORIAL TROPHY is to be awarded at the PACIFIC COAST YACHTING ASSOCIATION annual meeting to a member organization.

The form of the report, and its submission date, may be determined by the officers of the PACIFIC COAST YACHTING ASSOCIATION, as shall judging criteria. One judge from each of the member areas (Pacific Northwest, San Francisco, Los Angeles and San Diego) shall be appointed by the current PCYA Commodore, with a balance between the sail and power organizations. The current PCYA Commodore will act as the fifth judge, and the decision of the judges will be final.

The GARRETT HORDER MEMORIAL TROPHY may be awarded to any member organization. No subdivision of the member organization may receive the trophy more than once in any three year period.

This DECLARATION OF TRUST may be amended at any annual meeting of the PACIFIC COAST YACHTING ASSOCIATION by a majority vote of the directors present providing a quorum is present.

DEED OF GIFT CHARLES A. LANGLAIS TROPHY

As Amended June 9, 2002

In order to promote the sport of yachting and to encourage resistance to harmful actions CHARLES A. LANGLAIS, hereinafter referred to as the donor, gives to the Pacific Coast Yachting Association, hereinafter referred to as the donee, a sterling silver trophy under the terms and conditions hereinafter set out:

I. NAME: The Trophy shall be named, "The Charles A. Langlais Trophy"

II. DESCRIPTION: The Trophy consists of a sterling silver loving cup mounted on a teak base bearing plaques for the names of the several recipients.

III. HISTORY: This Cup was won by the Donor sailing the R Boat, LADY GAY at the 1926 Championship Regatta of the Pacific Coast Yachting Association and presents it this year, the 50th anniversary of the Trophy.

IV. AWARD: This Trophy may be awarded not oftener than once in any calendar year by the Board of Directors of the Pacific Coast Yachting Association and, if so awarded, shall be presented to the recipient at the Annual Meeting of the Association.

This Trophy shall be awarded, only to a member of the yacht club which is a member of a Member Association of the Pacific Coast Yachting Association by affirmative vote of the Board of Directors for exceptional, outstanding and meritorious service to the sport of yachting, not for successful competition but including such success as exceptional seamanship, sportsmanship or any achievement which shall protect or promote the sport of yachting in its broadest configuration.

Any member Association may nominate a candidate in writing addressed to the Commodore of the Pacific Coast Yachting Association at least ninety (90) days prior to the date of the Annual Meeting.

The Pacific Coast Yachting Association Vice Commodore

and the immediate past recipient will be Co-chairmen and the five most recent available recipients will constitute the Nominating Committee. This Committee shall, after careful review of all nominations submit its recommendation to the board of Directors of the Pacific Coast Yachting Association during the Annual Meeting. The Board of Directors shall either accept or reject the recommendations of the Nominating Committee, but shall not select a different recipient.

V. CUSTODY: The Trophy itself shall be maintained and insured by the donee and may be delivered to the recipient or his yacht club, as the Board of Directors shall determine from time to time.

The donee shall provide a suitable take-home trophy for each recipient. The Trophy shall be returned to the Secretary of the donee not later than the Annual Meeting of the Association following the calendar year in which it was awarded so that the Trophy may again be presented. If not awarded, the Secretary shall retain custody until it is next awarded.





able, considering length and type of engines. There were no bad boats on the list. When I popped the balloon my wife picked out, the boat was the "Forever," a 32 ft. gas powered Unifite. It is sad to say now, it was not in the top five of our wish list, but we knew we would have to make do. The owner, Neil McClelland introduced himself and assured us that his boat was championship quality. Boy was he right. Neil's enthusiasm for racing and boating was overwhelming with such a positive attitude.

The next day we went out to do the measured mile, but there was no measured mile. The authorities had recently removed the markers in English Bay so we were told of a half-mile course in the harbor. I think most of us got enough data before we were run off by the harbor patrol. It seems the course was off commercial docks, which were having ship movements at the same time. After the time runs, we met with other racers to discuss the course and currents for the next day's race. After listening to theories of water volume virus area, eddy currents, and other various good ideas, we decided to stick with our own predictions of what the current would be. We printed out the entry forms and went to dinner to a very fine restaurant over looking Vancouver and enjoyed ourselves with friends and good wine.

The next morning we woke up to a rainy day but our spirits were high. When we got to the boat, Neil had put a sign on the side of the boat that said "THE LITTLE BOAT THAT COULD, I

THINK I CAN, I THINK I CAN". It became our rallying cry. We started the race on the fly bridge, but quickly figured out that it was to wet and cold to stay outside, so we moved to the lower helm, which was a lot more comfortable. As soon as we got settled into the race, Linda took over the helm. She may be small but you do not want to get in her way of maintaining her course. Jeff and I kept checking our position and having a lot of spirited discussion about what throttle adjustments where needed to correct for the currents we thought were present. On the final leg, when all the boats were getting closer together, we had to past through a narrow passage called Second Narrows. Everything was going great until a tanker and two tugs appeared out of the heavy mist. We decided, like half of the fleet, there was not enough room for all of us, so we took over a twelve-minute time out prior to adventuring to the finish line.

On the way in from the finish, Pat Johnson, our seasoned observer, was on the spot and had already started figuring out our actual leg times. When you are so keyed up, it sure is nice to have someone who can add and subtract times. Neil expertly skippered the "Forever" back into its moorage, while the team relaxed and had a libation. We then figured out our percentage of error and were pleasantly surprise with a 1.3201% of error with handicap. We felt good about our score and how we performed during the race, but did not have any idea how we did compared to the rest of the field. The one

thing we knew was The LITTLE BOAT THAT COULD performed very well.

The banquet and peel off was held at the Burrard Yacht Club that evening. They had the tables numbered in the order that we were to get in line for dinner. It started out good for the team by being seated at the first table, and it got better from there. The dinner was very good with excellent Canadian wine to help settle the excitement. The peel off was done with a computer projection presentation that was very easy for everyone to see. As the best of legs were being shown, it was apparent we were going to be in the running for a top three finish. We did have a one second error on leg six, for which we were happy to receive a bottle of Merlot. When Bob Lindal, IPBA-North took third with a 1.3344% and George Babbitt, IPBA-South, was second with a 1.3251%, I realized we had won the 2007 Barusch Race and was part of the winning team of the Castagna Award with THE BOAT THAT COULD. It was a very overwhelming moment for both my wife Linda and me to achieve our goal of winning both of these trophies with our good friends Jeff and Claire Swan.

We want to thank PCYA, Joe Castagna, IPBA Gulf of Georgia, Burrard Yacht Club, and anyone else that put on this memorable weekend for all the contestants. I'd like to offer a special thanks to Neil McClelland for his gracious use of THE LITTLE BOAT THAT COULD.
